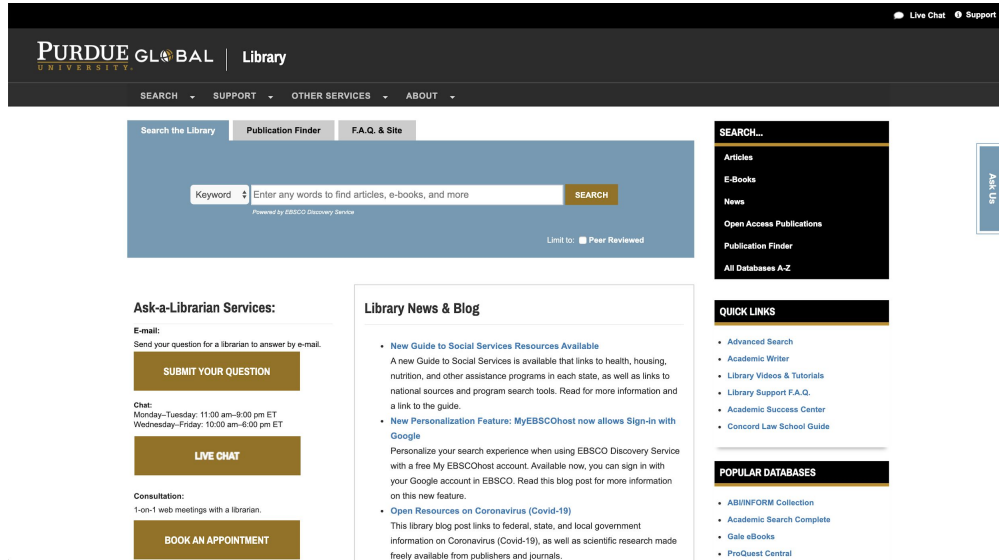

Scholarly Communication

According to the ACRL, scholarly communication is how research and scholarly work is created, evaluated, disseminated, and preserved.

- Formal communication: Peer reviewed journals
- Informal communication: Email lists

Scholarship is a conversation, following a sometimes complicated constellation of resources and needs.

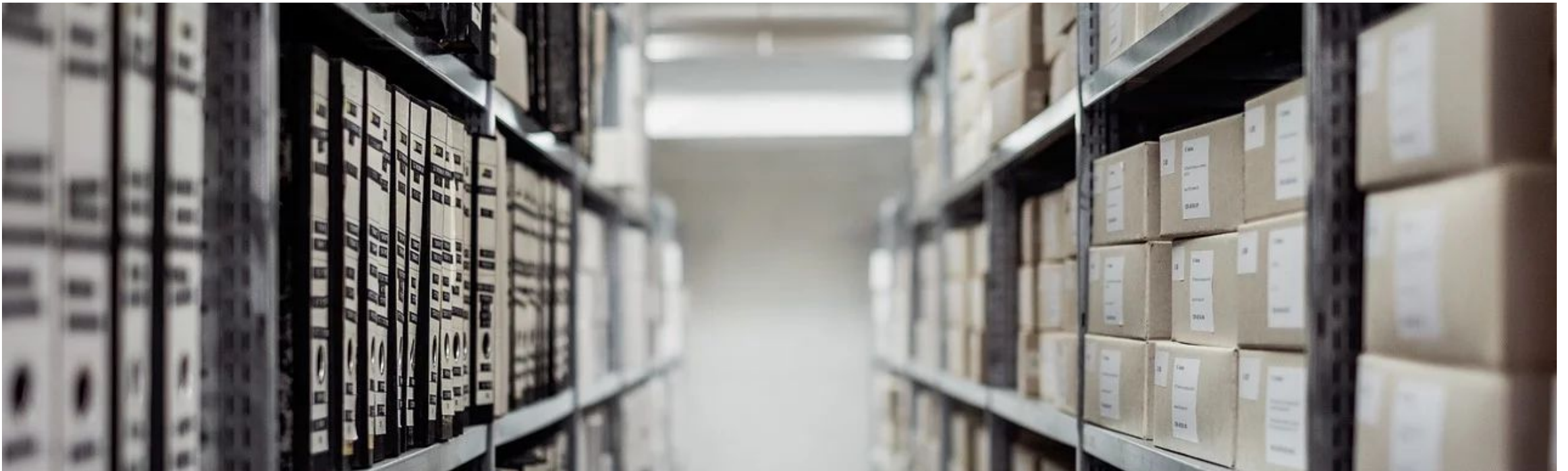
One of those needs is the need to share.



Sharing in an Institutional Repository (IR)

GEC 2020

A service that organizes, preserves, and shares the scholarly work and other academic activities at the institution.



Types of Publications

GEC 2020

Examples of the types of publications typically found in a repository:

- Scholarly research articles
- Working papers and other pre-publication research works
- Conference proceedings
- Dissertations and theses
- Image collections
- University newsletters and other official communications
- Other university documents (ex: course catalog)

GEC 2020

Policies

- Benchmark review of policies and documentation at other universities.
- Leadership presentation and one-on-one discussion with deans.
- Draft of policy document reviewed by leadership and integrated into public-facing documentation.



Policies

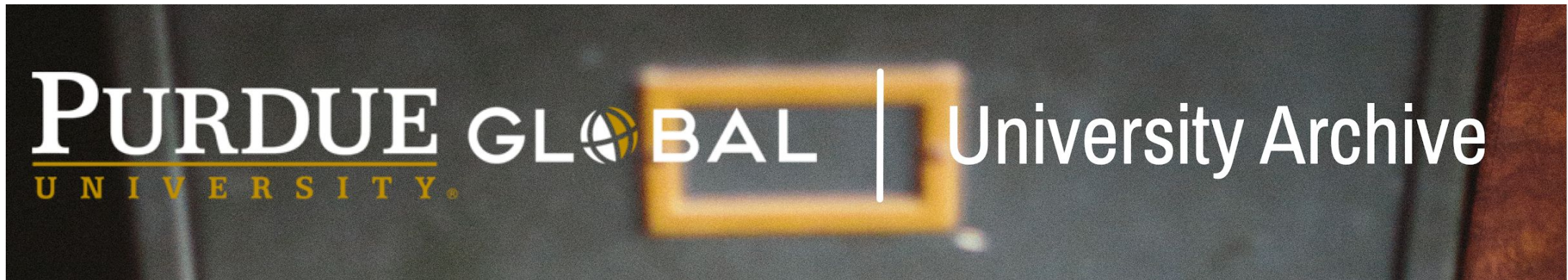
GEC 2020

- Any faculty or academic staff associated with the university may contribute.
- Students, including alumni, will be able to contribute in the future, to specific collections.
- Scholarly articles and presentations must mention PG (or KU, if created before 2018).
- A wider array of collections, more than just "Faculty Publications" are possible, to accommodate presentations and other kinds of work.
- We will accept citation and abstract-only submissions. However, we ask due diligence from the contributor in evaluating if they can submit the full-text copy, as this is the most desirable.

Promotion

GEC 2020

- Naming an IR: More challenging than it sounds!
- Common examples: Digital/Scholarship Commons, Scholarship @, Archive, or just Institutional Repository.
- PG University Archive chosen.
- Advertising the IR: Link placement, calls for participation, presentations, email blast.

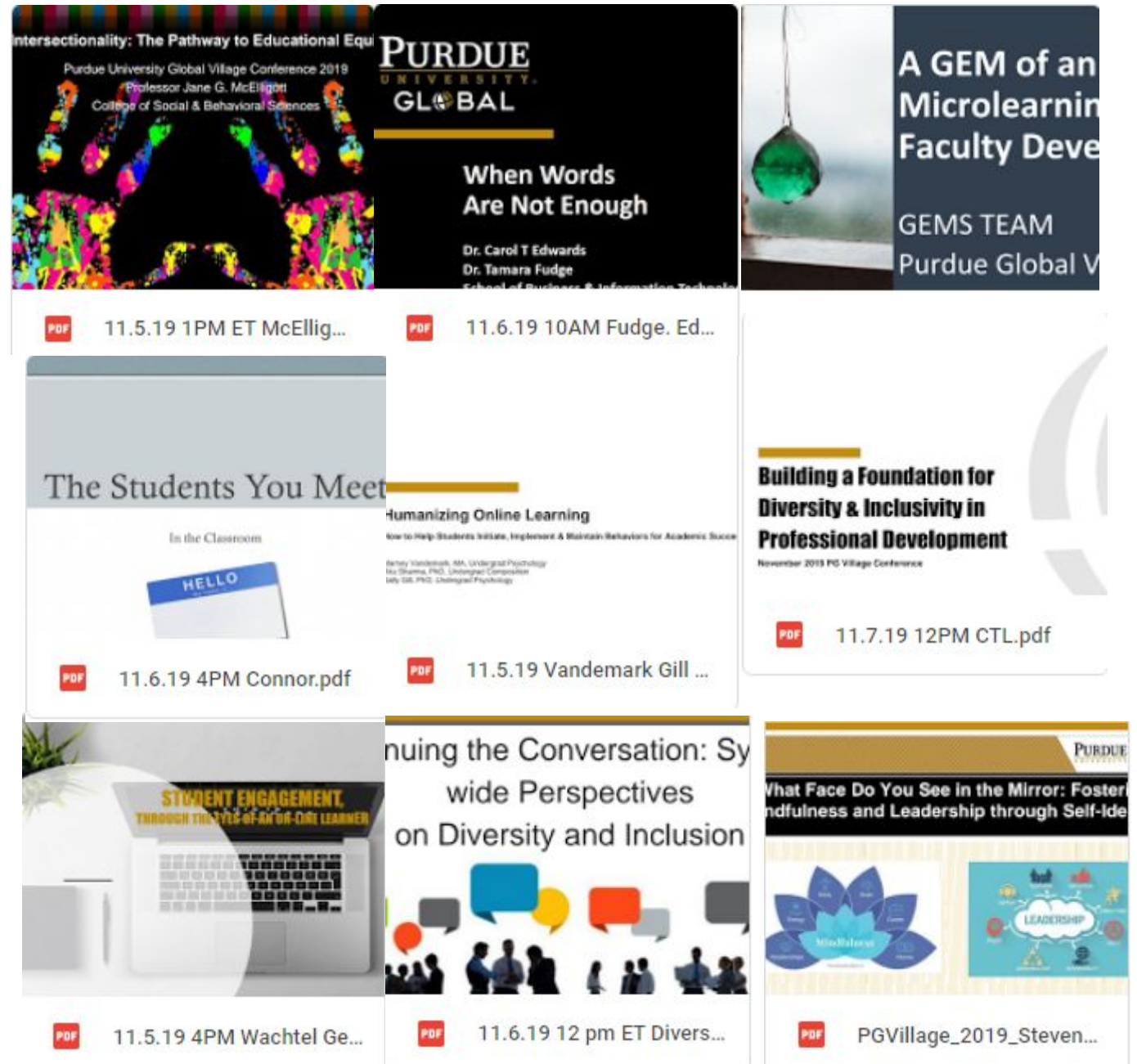

Creating Successful Professional Development Activities for Online Faculty: A Reorganized Framework

Abstract:

In the online environment, faculty engagement in the form of professional development takes on a new significance. Online programs hold strategic importance and growth opportunities for institutions, and therefore universities need faculty members who are engaged and effectively teaching in the online environment (Allen & Seaman, 2013, 2016; Dennis, 2013). Faculty professional development provides a vital component to overall faculty engagement and student success in the online environment. Extant research shows that when faculty members are active within the university, they are also likely to be engaged in the classroom (Drew & Kloppe, 2014; Umbach & Wawrzynski, 2005.) Effective professional development specifically offered for online faculty needs to provide additional layers of support to help foster community, support faculty use of technologies, and meet university requirements (Meyer & Murrell, 2014). This paper presents a reorganized, more systematic professional development framework for online faculty that enhances virtual opportunities and support within the domains of personal considerations and interpersonal relationships (Caffarella & Zinn, 1999; Cervero & Daley, 2016). The approach developed in this paper reorients and extends an existing conceptual construct by placing greater emphasis on the development of a community of learning in order to help faculty develop strong pedagogical practice in teaching in order to both meet university requirements and foster increased student success.

A Qualitative Study: Military Veterans and Franchise Ownership

Abstract:

This study focuses on the military experience and motivation to become a franchise business owner. Previous research indicated franchisees who were military veterans had a significantly higher level of job satisfaction in owning and operating a franchise compared to franchisees with no military background. This study attempts to provide answers to important research questions like how and why military experience influences satisfaction in owning a franchise. Seven franchise business owners who served in the military participated in this qualitative study using a process of surveying, coding, and thematizing to answer this research inquiry. The findings of this follow-on study indicated veterans had strong negative sentiment towards bureaucracy, however did value the positive aspects of systems within the franchise construct. In addition, the veterans valued their prior learning related to military experience and leadership and perceived it as a key strength towards successful franchise leadership and business ownership. One of the main aspects of business ownership and leadership that veterans valued more than other concepts was control, which connects to the traditional aspects of control within the business profession.

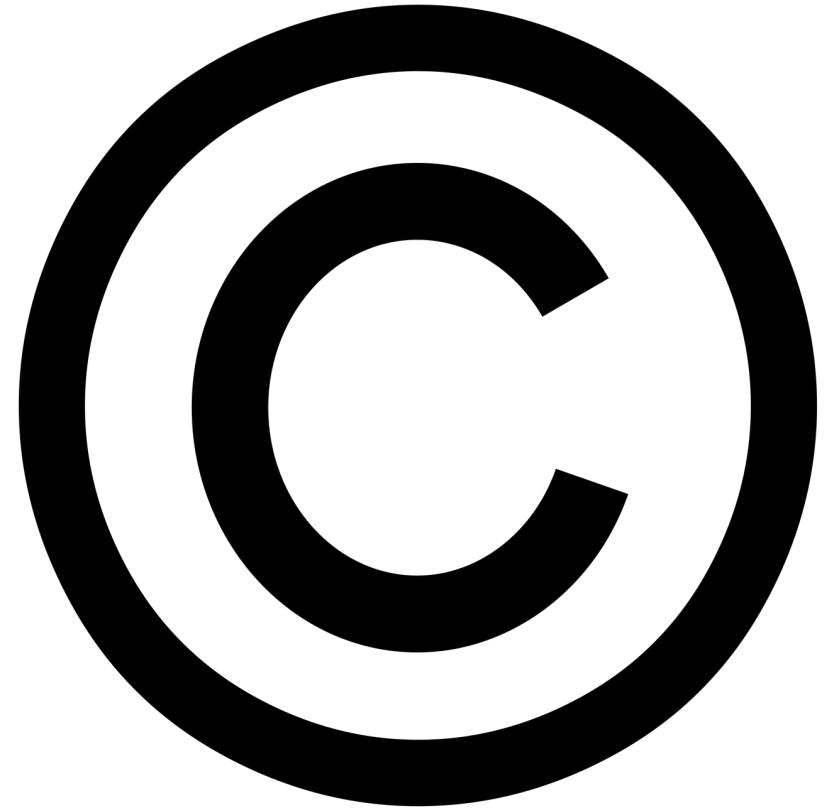

- You wrote it, but you may not own it.
- Many publishers require copyright transferred to the publisher.
- Copyright law applies to authors, libraries, and repositories/archives.



Fair Use

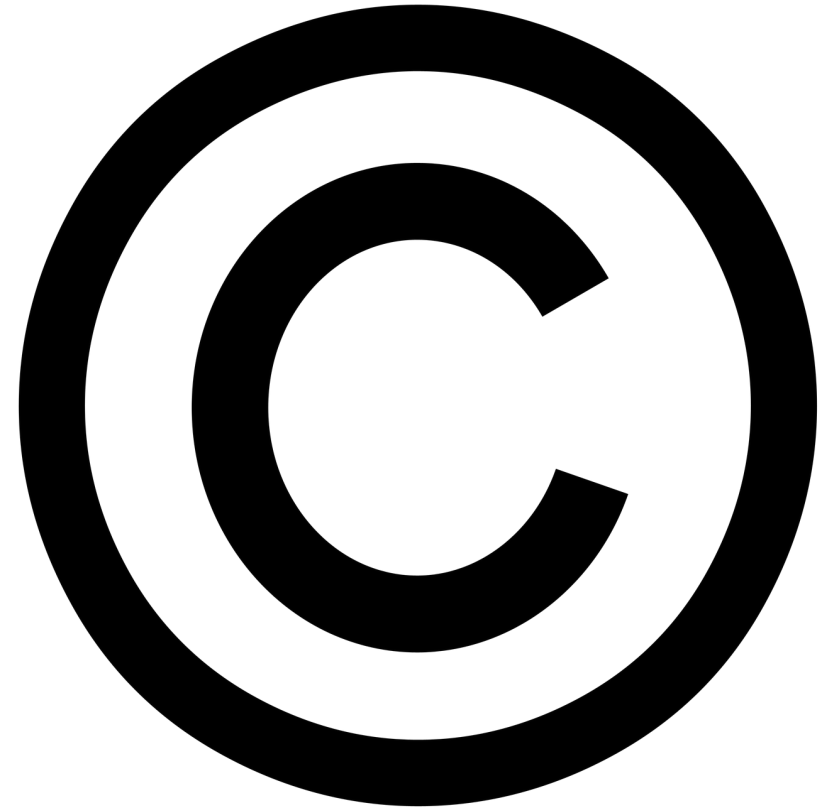

Fair Use:

- Descriptive Information like title and author
- Abstract, if included as part of the article

Not a fair use:

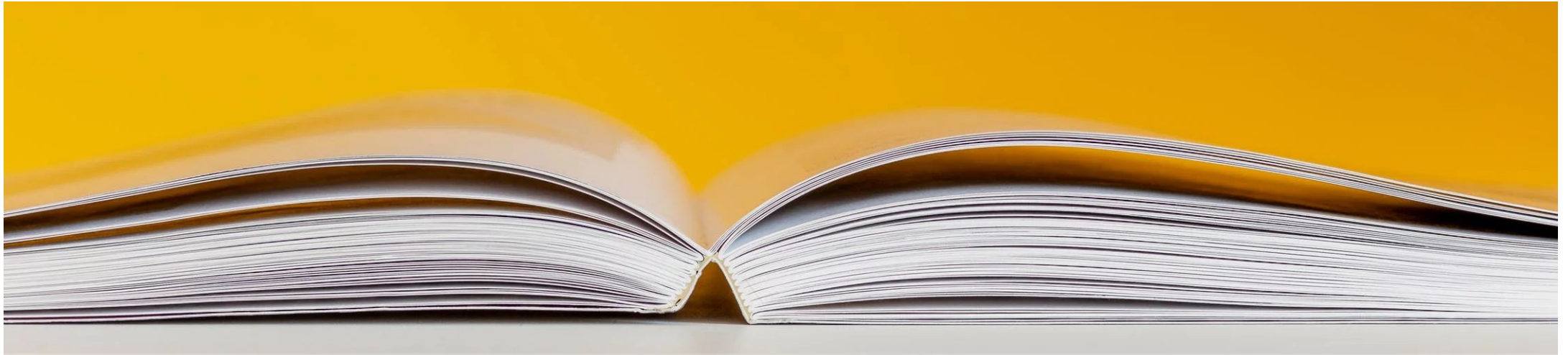
- Uploading the full text of the published copy without permission
- Uploading an abstract in cases where the abstract is separate from the article, or the whole work



Most Major Publishers Allow Self-Archiving

GEC 2020

- Major publishers allow self-archiving in a repository
- Most allow the pre-print or post-print
- Fewer allow the published version
- Associations less likely to allow self-archiving
- Open access journals almost all publish under Creative Commons, which allows sharing anywhere, including the University Archive



Checking Your Rights

- Check your signed publishing agreement
- Check publisher's site
- Check website SHERPA/ROMEO:
v2.sherpa.ac.uk/romeo/
- Look for mentions of self-archiving or sharing on a university archive or institutional repository.
- Ask Matt for help.

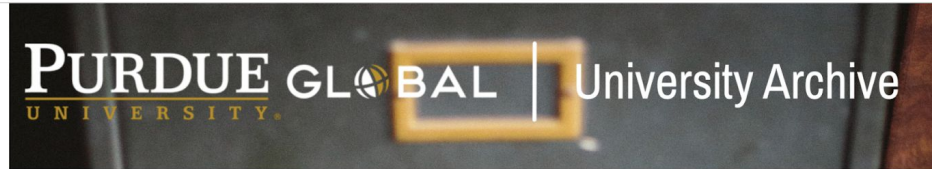
